## ACQUISITIONS FY 2013

**July 2013:** PropertyFirst GmbH, Bochum, Germany, purchases DCM Real Estate Management GmbH, Munich, Germany, from the insolvency estate of DCM Deutsche Capital Management AG, Munich, Germany.
